- 1. Meeting was Called to Order 6:45
- 2. Roll Call Amanda Bloom, Kathy Bloom, Bonnie Bernard, Ann Job, Cheri Blose, Les Aisenman, Sharron Aisenman, Sherry Lincoln, Maria Silva, Patti Rau, Peggy Courtney, and Kathy Grubert. Amanda and Kathy Bloom, and Kathy Grubert left immediatly so as not to be in violation of Brown Ace.
- 3. Housekeeping: Sign-In Sheets, Speaker Cards, Recording, rules and Code of Conduct
- 4. Welcoming Stakeholders and Guests.
- 5. Public Comment on matters not appearing on the agenda.
- 6. Discussion and possible action to approve the Minutes from the last Outreach Committee meeting.
- 7. The committee, after discussion and a unanimous vote, decided to recommend to the Board that the colors to associated with the Sylmar Neighborhood Council will be light tan and forest green.
- 8. The committee, after discussion and a unanimous vote, decided to recommend to the Budget Committee, the purchase of a countdow timer, not to exceed \$150.00.
- 9. The committee, after discussion and a unanimous vote, decided to recommed to the Budget Committee, the printing of a 3-panel, double-sided SNC brochure in color, not exceeding \$650.00.
- 10. The committee, discussion and a unanimous vote, decided to recommend to the Budget Committee the purchase of a pop-up tent, with Sylmar Neighborhood Council on all 4 sides, and accessories including but not limited to roller bag, weight bag kits and stakes, not to exceed \$1,500.00.
- 11. The committeed, after discussion and a unanimous vote, decided to recommend to the Budget Committee the purchase of 2 6' table covers, with front panel logo. 1st by Bonnie Bernard; 2nd by Ann Job. Recommendation was made to use the City Seal on the tent and table covers, 1st by Bonnie Bernard; 2nd by Ann Job. The vote was unanimous.
- 12. The committee decided to postpone the purchase of Pole-mounted Flags until the next fiscal year so as to have more time to research this proposal.
- **13.** The committee, after discussion and a vote of 5-0-1, decided to recommend to the Budget Committee, the purchase of 3 shirts, embroidered with "Sylmar Neighborhood Council". The committee also recommended further exploration of this matter during the next fiscal year. 1st by Bonnie Bernard, 2nd by Maria Silva.
- 14. The committee, after a discussion and unanimous vote, decided to recommend to the Budget Committee, the sponsorship at the Firend Level for Pacoima Beautiful's Environmental Justice Award at the June 18, 2015, event, not to exceed \$1,000.00.

According to Betty Wong, this request should be put through as a Neighborhood Purpose Grant. 1st by Bonnie Bernard, 2nd by Maria Silva.

- 15. The committee, after a discussion and unanimous vote, decided to recommend to the Budget Committee that this Neighborhood Purpose Grant be approved in an amount not to exceed \$750.00. Betty Wong, at DONE, informed Ann Job that due to the time of year and the desire of neighborhood council to spend any money they have spend, that it was approved, even though the event does not occur until October of the next fiscal year. 1st by Maria Silva, 2nd by Ann Job
- 16. The committee, after much discussion, decided to recommend this item to the Budget Committee to determine if the Council could purchase a BarBQ Grill and jerseys for the girls' basketball team. The jerseys will have on them "Sponsored by the Sylmar Neighborhood Council".
- 17. The committee, after discussion, decided to refer this item to the Budget Committee to see how the Council could assist with the needs of the homeless of Sylmar. Cheri Blose suggested that since the Graffiti Busters application for a NPG was turned down, and that money was still on the budget for their NPR, that the Council use that money to assist the homeless
